## Industry Updates

- **IRS Finalizes 2026 Reporting Changes**

Under the “One Big Beautiful Bill Act,” the 1099-NEC and 1099-MISC thresholds will increase from \$600 → \$2,000 starting in the 2026 tax year. Contractors should update internal tracking now.

---

- **CMMC 2.0 Integration Expands**

More DoD solicitations released in Q1 2026 are expected to include CMMC Level 1 or Level 2 requirements. December is an ideal time to complete readiness assessments.

---

- **DCAA Updates Guidance for PBR Submission**

The DCAA Contractor Submission Portal (CSP) continues to roll out improvements for PBR and ICS filing acknowledgments.

---

- **Small Business Threshold Reviews Underway**

SBA is currently reviewing NAICS size standards for FY26, which may impact your small business eligibility for recompetes.

## Quick GovCon Tips

- **Reconcile All Open Accounts Before 12/31**

Bank, credit card, payroll, unbilled A/R, and accrued expenses should be fully tied out to avoid 2026 audit delays.

- **Confirm Your Final Invoice Submissions**

Ensure December invoices reflect accurate labor, indirect rates, and allowable costs—especially for cost-reimbursable contracts.

- **Verify Vendor Compliance for 1099-NEC/MISC**

Ahead of the 2026 threshold changes, update W-9s and confirm vendor classifications now.

- **Check Contract Funding & Modifications**

With continuing resolutions in place, confirm that December work is properly obligated to avoid stop-work notices.
